

Ag States of America 2024 Trivia Sweepstakes

Official Rules

- 1. Who Can Enter:** Entrants must be legal United States residents who are at least 18 years of age or older and have lawful access to the method(s) of entry set forth in the rules.

- 5. Prize Drawing:** On or about January 15, 2025, the Sponsor will randomly select fifteen (15) names of entrants that have answered trivia questions correctly. The process for random selection and the location of the prize drawings shall be determined solely by the Sponsor.

- 6. Prize, Approximate Retail Value (“ARV”) & Odds of Winning:** Total ARV of the Prize is 100.00. Odds of winning are contingent upon the number of entrants who answer the weekly trivia question correctly.
